- 1. Bid form (in the required format) duly signed by an authorised signatory;**
- 2. Authority to sign on behalf of the bidder or Power of attorney duly sealed;**
- 3. Bid security of Kshs.2,500,000.00 in form of Bank Guarantee from a reputable bank or approved Insurance Company;**
- 4. Duly filled and priced Bill of Quantities;**
- 5. Joint venture agreement in the case of a joint venture bid;**
- 6. One original bid and three (3) matching copies orderly organised;**
- 7. Registration with National Construction Authority (Category NCA 3 and above);**
- 8. Certificate of Incorporation;**
- 9. Valid Tax Compliance Certificate;**
- 10. Proof of works of similar magnitude and complexity undertaken in the last five years (Indicate Technology Used);**
- 11. Adequate equipment and Key personnel for the specified types of works;**
- 12. Sound financial standing and adequate access to bank credit line equal at least 10% of the Tenderer's sum;**
- 13. Litigation History of the Company (both court and arbitration cases);**
