Contractors who are registered in relevant trades and categories, (proof of registration required) can obtain a softcopy of the Bidding Documents free of charge from www.housingandurban.go.ke

Bidders should note that only those meeting the criteria indicated below as a minimum, supported by relevant documents at submission will be considered for further evaluation.

1. **Certificate of company. Firm registration;**
2. **Updated list of directors with respect to shareholding & details of citizenship which should not be more than 6 months at the time of tender opening;**
3. **Copy of valid Tax Compliance Certificate;**
4. **Audited accounts for each of the last three years(i.e. 2016-2018) with annual turnover of at least Kenya shillings Five Hundred Million (Kshs 500,000,000.00);**
5. **National Construction Authority (NCA) Registration category 1 and above for Building Main Works and NCA 3 and above for Specialized Subcontractors (Electrical and Mechanical Works)**
6. **Current annual practicing license from the NCA;**
7. **Bid Security of Kshs. 5,000,000.00 in form of a guarantee from reputable bank or Insurance Company approved by PPRA and located in Kenya and valid for 150 days from the closing date of the tender;**
8. **Power of attorney (of Tender signatory);**
9. **Signed and stamped statement of Verification that not debarred in matters of Public procurement and Disposal Act. (Form attached);**

10. Dully filled and signed tender questionnaire;
11. Dully filled business questionnaire;
12. Tenderers who have incomplete projects and do not have approved extension of time or have received default notices / warnings are not responsive
13. Original bid and three (3) matching copy orderly organized;
14. Litigation History of the Company (both court and arbitration cases);
