The **State Department** for Housing & Urban Development invites sealed bids from eligible candidates for the Proposed Construction of Chaka Market Hub – Phase II in Nyeri County.

The Mandatory requirements for the prospective tenders: -

- (a) Must be registered with the Registrar of Companies and other relevant bodies (Proof of registration must be attached)
- (b) Must have valid tax compliance certificate.
- (c) Bidders Must provide a bid security of **Kshs. 400,000.00** in form of a Bank Guarantee from a reputable bank or other approved financial institution. The bid security validity should 30 days beyond tender validity period (**150 days**).
- (d) Must be registered with NCA in the Categories indicated in specific Bid Documents (NCA 1 and above for Building works and NCA 5 and above for specialized works in case of domestic subcontractors)
- (e) Must provide updated list company directors (recent copy of CR12)
- (f) All interested bidders must attend a mandatory pre-tender site visit on **2nd March 2020 at 10.00 a.m.** at the Chaka site among other requirements as detailed in the tender documents.
